Food review: Bath River Cottage Canteen

• When it first came to town, the easygoing cabaret/comedy pleasuredome Komedia offered little to smile about in terms of food. But with the introduction of River Cottage Canteen, mop-topped tasty toff Hugh Fearnley-Whittingstall has turned the tide.

The collaboration blends Hugh's principles concerning sustainability and responsible sourcing with Komedia's mission to establish itself at the epicentre of Bath's entertainment schedule.

By day, the cafe transforms the venue's foyer into a quirky but welcoming diner, with fresh produce and stylish images of happy lambs scattered artfully throughout. Furniture is either recycled or made from wood from renewable sources, the paintwork is environmentally friendly and even the electricity supplier is described as 'green'. Meat, poultry and dairy produce are organic and locally sourced, fish is landed by day boats in the West Country and imported 'exotics' are either organic, Fairtrade or both.

While the food couldn't be described as cheap (light lunches start at around £7, more substantial dishes nudge the £16-£17 territory), it is most definitely cheerful. A velvety pork liver pate came with fruity homemade pickles, tangy chutney and a wholesome wedge of granary bread; the deeply mature cheese sauce in the Welsh rarebit teemed with leeks; a Scotch egg with chive and mustard mayonnaise was a miracle to behold – the joy of watching a very fresh yolk ooze into smooth, porky sausage meat and soft, golden breadcrumbs was an unforgettable delight.



Breakfast is served from 7.30am and, when the cafe reverts back to foyer status at 5pm, you can tuck in while taking in a show - that's entertainment, indeed.

River Cottage Canteen @ Komedia

Hidden gems...

There's more to Bristol and Bath than the Suspension Bridge and the Thermae Bath Spa. If you know where to look, you'll find an abundance of fascinating, fantastic little treasures. We count down 10 of our favourites, from pubs to parks, in no particular order...

1 Nightingale Valley and Paradise

▲ Bottom If the names alone aren't enough to draw you to the southern and northern reaches of Leigh Woods (respectively), then the glorious variety of flora and fauna waiting for you there should be enough to get you reaching for your wellington boots. *Leigh Woods, Bristol* **2 Clifton Observatory** Get priceless views of the Avon Gorge via Clifton Observatory's viewing platform, which hangs some 250 feet above the valley floor beneath. You'll need to walk through St Vincent's Cave to reach it. Claustrophobics need not apply. *Near the Suspension Bridge, Bristol*

Arnos Vale Cemetery This huge necropolis, opened in 1839, is the final resting place of some of Bristol's most important figures. Undergoing a major restoration that should be finished by autumn, chuck a few quid into the collection box and get lost among its fascinating Victorian memorials. *Bath Road, Bristol*

4 Margaret's Buildings Gorgeous little row of shops (above right) a stone's throw from The Circus (keep your eye out for famous resident Nicolas Cage), the jewel in Margaret's Buildings' crown is the delicious Hansel and Gretel Shop and Strudel Bar. *Off Brock Street, Bath*

 $5 \underset{pub}{\text{King William}} \begin{array}{l} \text{Stylish, snug and cheery little} \\ pub (top right) about a 10-minute walk from the centre serving up locally sourced and organic grub in eclectic, bijou surroundings. What's not to like? 36 Thomas Street, Bath \end{array}$

6 The Cornubia ... and while we're on the subject of smashing little boozers, this is Bristol's own diamond in the rough. One bar, two rooms, simple grub and guest beers from local



microbreweries have given this place a cult-like following. You'll see... 142 Temple Street, Bristol St Mary Redcliffe Of course, we're not suggesting that Bristol's most famous church is a hidden gem. Rather, the piece of tram-rail stuck in the graveyard courtesy of a WW2 air raid is worth a look, as is the memorial to the church cat. Redcliffe Way, Bristol

Beese's Riverside Bar and Tea Gardens You'd be hard-pushed to find a nicer spot in the city on a hot summer's day. Bristol Ferry Boat Company runs regular 'cream tea' cruises from Welsh Back or park in Conham Road car park, follow the riverbank round to the steps, ring the bell and wait for the Conham Ferry to transport you across the Avon. Wyndham Crescent, Bristol

George V memorial garden Grab your book, head over to Henrietta Park in Bath and take a seat in the lovely but virtually deserted George V memorial garden, with its rose-and-wisteria covered pergola and tranquil pond. Off Laura Place, Bath

10 Blaise Hamlet This scrumptious little hamlet of nine unique cottages, all set around a small but perfectly formed green, was designed by John Nash in 1809 to house Blaise Estate pensioners. It's like Bristol's version of the Shire in the heart of Henbury. *Henbury, Bristol*

The CV

 It is a hook to obtain a meeting and should not (ideally) exceed two pages.
 It should be easy to read – consider font form and size, spacing, boxes, white space, colour. The most relevant information should be on the first page.

3. It should contain anything (positive!) that sets you out from the crowd.

4. It should be adapted for each application
5. Do your homework and research the firm.
Keep in mind the advertisement/firm/reader
what do they do, what are they looking for, why do you want to work there and how do you fit the bill?

6. Spend a great deal of time and care on the CV and application form. Check spelling and grammar. Ask a friend/colleague/lawyer to read and comment on it.

7. Keep it updated and safe in IT and paper form.





The Interview

- **1.** Know the firm.
- 2. Know the role
- 3. Know the law.
- **4.** Know yourself (and your CV).

5. You can never do enough research on the firm and role – use every resource available.
6. Make sure you are up-to-date with any recent developments in your area of law and know about the commercial and business environment - read the legal press and the broad sheet.s

7. Find out what form the interview will take. Prepare for questions on your CV especially awkward ones - gaps / inconsistencies/poor grades etc.

8. Prepare your own questions for the interviewers e.g. the firm's vision/strategy; supervision/training and development; career progression.

And remember – the interviewers will be looking at basic, simple things like 'Could I share an office with this person?' and 'Could I trust them to have a sensible conversation with an important client?' At the other end of the spectrum, 'Would they be prepared to mend the photocopier if no one else was around?' and 'Would they go and get the teas on an all-nighter?'
